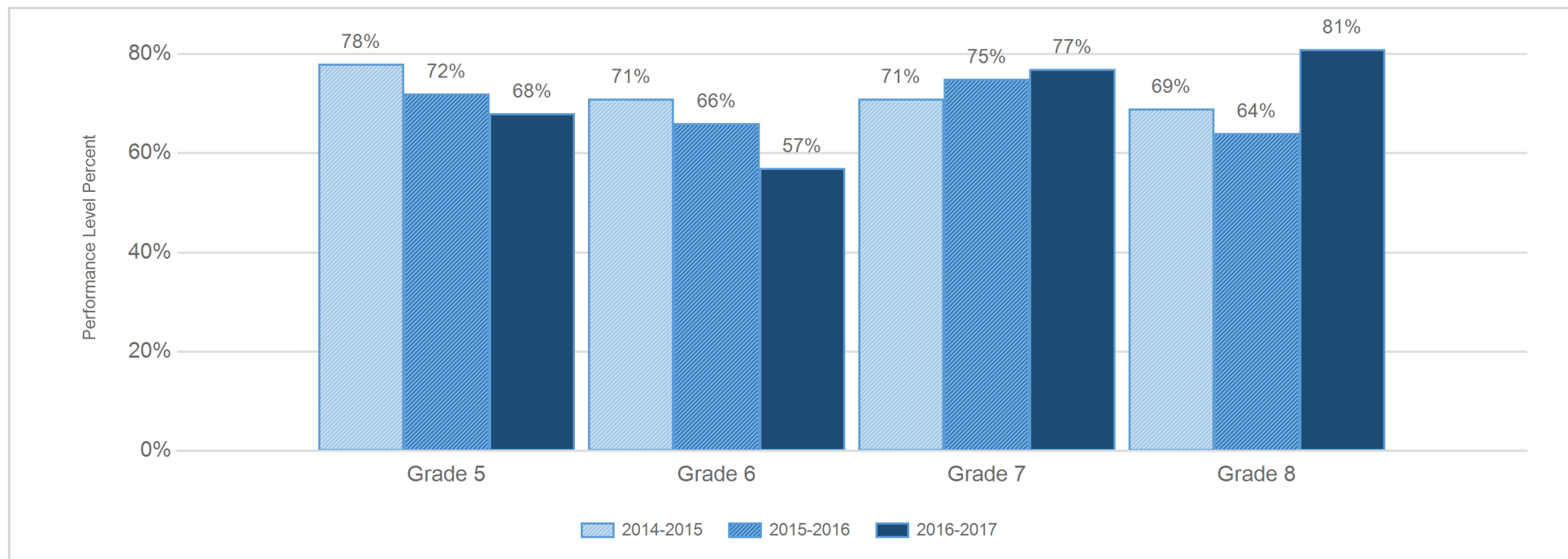

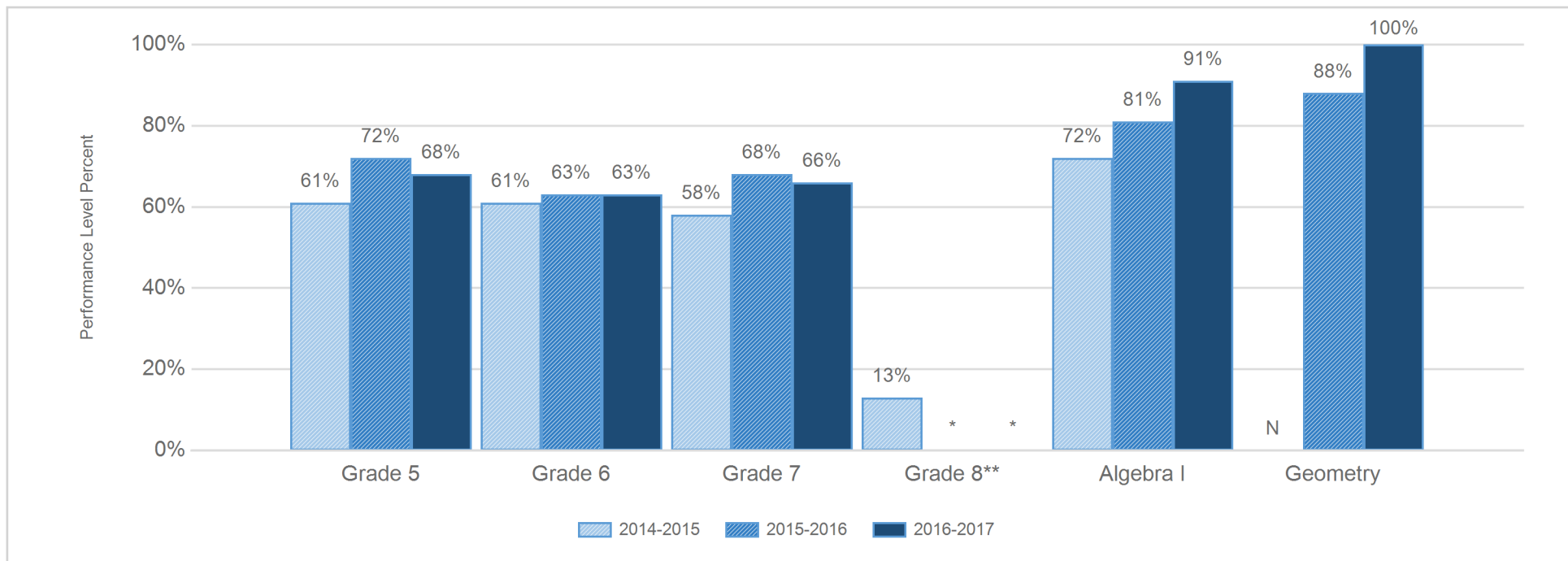

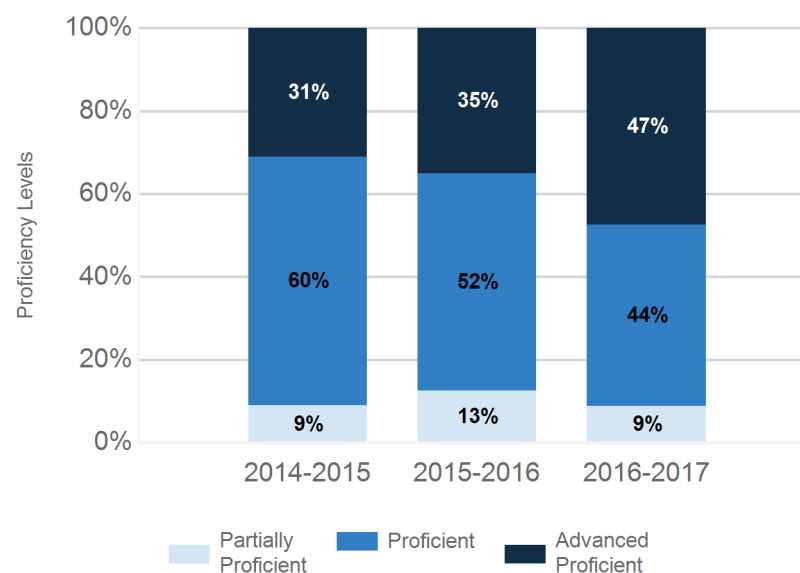

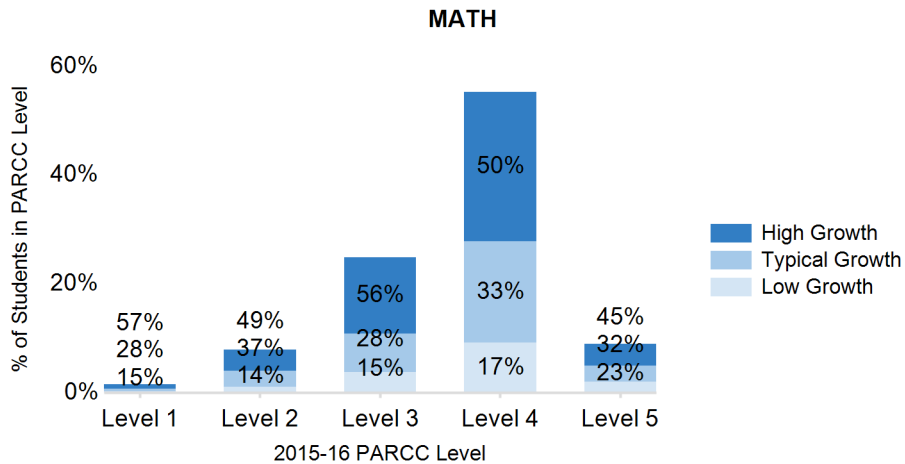

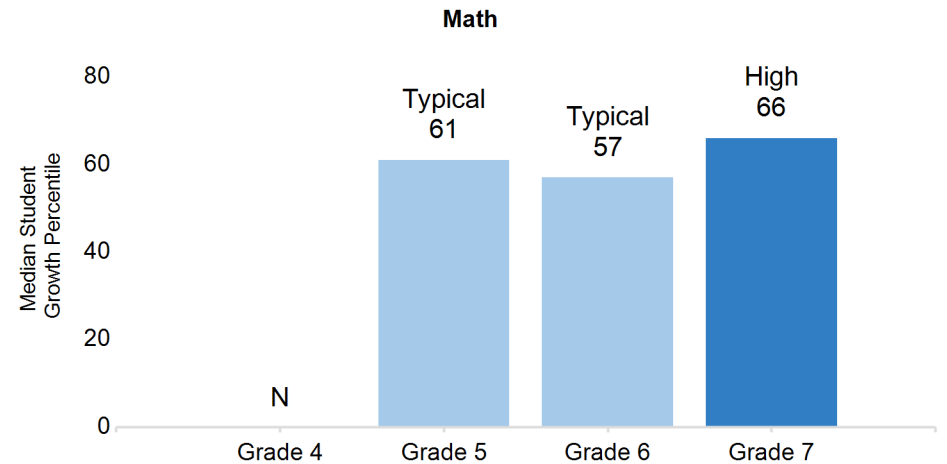
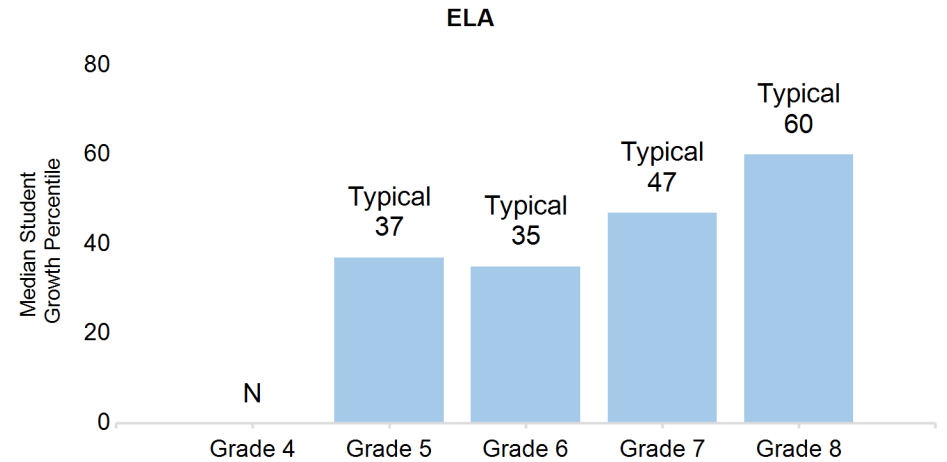

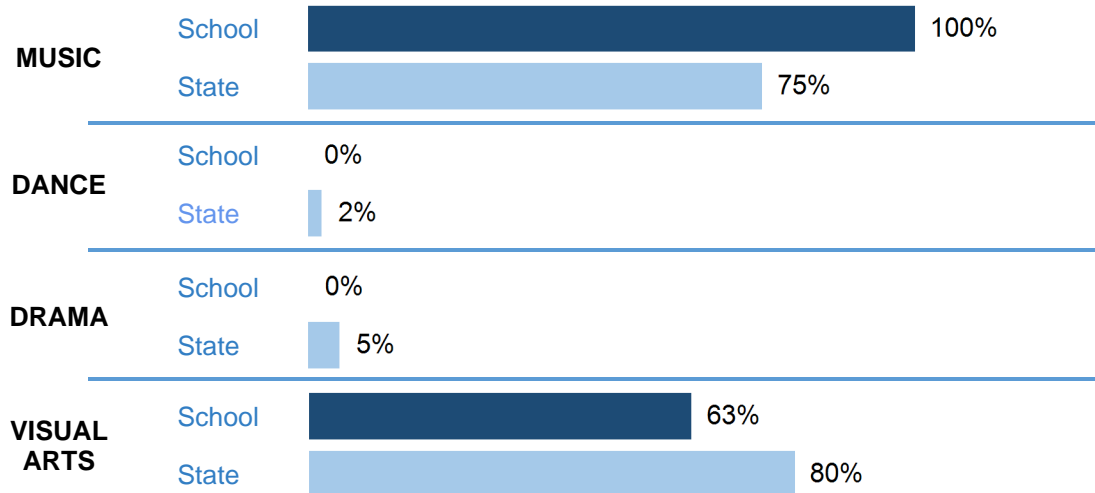

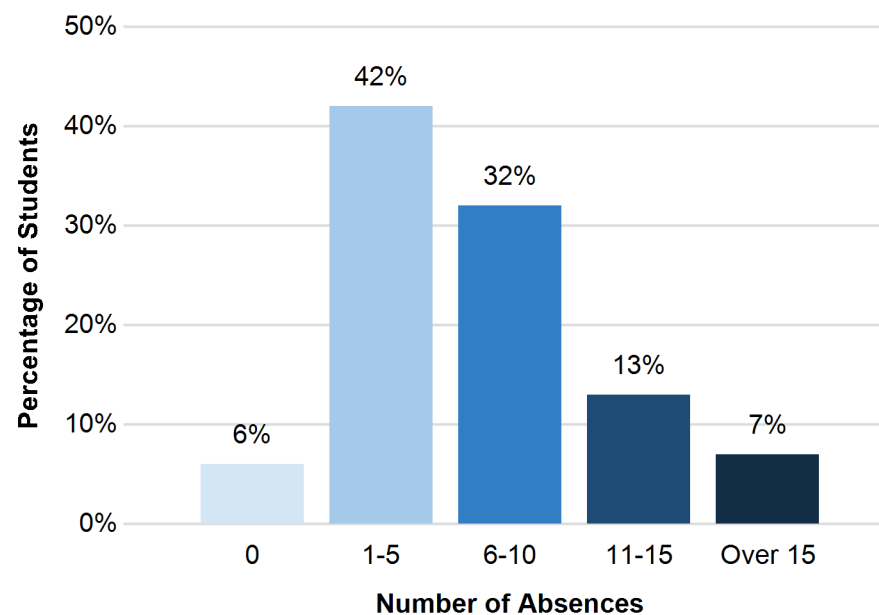

Full-Time Equivalent: In calculations, staff members are weighted based on the percentage of their time that they are assigned to a school or district. 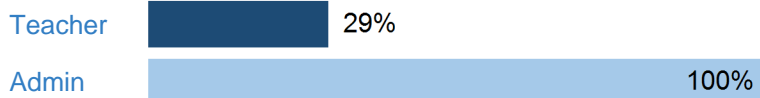
Teachers and Administrators - Level of Education
