ROBBINSVILLE BOARD OF EDUCATION PUBLIC SESSION MINUTES

March 23, 2010

I. CALL TO ORDER PUBLIC MEETING

President Mike Reca called the March 23, 2010 meeting of the Robbinsville Board of Education to order at 7:10 PM.

V. BOARD PRESIDENT'S REPORT – Mr. Michael Reca

Mr. Reca introduced the following individuals:

Mr. Gizzo recognized Student Academy Committee Members Annette Deck, Debbie Donoher, Jane Hutchison, and Kathy St. John.

On behalf of the student body, Dan spoke about what a great place RHS is and noted the positive impact RHS has on the entire student body.

VI. SUPERINTENDENT'S REPORT – Mr. Steven J. Mayer

Mr. Mayer shared his appreciation for the strong turnout (approximately 600 members of the public) and commented about the importance of creating a legacy that supports the values of the Robbinsville community. He and School Business Administrator Robert De Vita gave the 2010-2011 Budget Presentation.

VII. BOARD MEMBER COMMENT

After the presentation, several Board members expressed thoughts on the budget. They noted the special challenges the district faces this year in light of a \$1.7 Million reduction in state aid, particularly in the mandated areas of Special Education and Transportation. In Special Education, based upon State predications, the district expected to receive \$1.6 Million in aid. Instead, it will receive \$1 Million. In transportation, the district expected to receive \$920,000. Instead, it will receive no aid.

Board members encouraged the public to contact their legislators and express their feelings about Governor Christie's cuts in state aid.

Mr. Reca commended the administrators for volunteering to accept a wage freeze. He noted that a letter was sent to the Teacher's Association requesting a meeting but, to date, no response has been forthcoming.

VIII. HEARING OF THE PUBLIC

Panimal Patel

Mr. Patel expressed support for the Board and urged the district to try to find a way around the increase in health benefits.

Helen Dublas

Mrs. Dublas noted that there are three bills in the State Legislature regarding teachers chipping in for their benefits. Mr. De Vita indicated that the bills have passed and all districts are waiting for guidance from the NJ Department of Education. He added that if this is implemented next year, the district will save in excess of \$200,000.

Carol Wells

Mrs. Wells expressed support for the district. She asked decision makers to keep the taxpayer in mind. She noted the disparity between benefits offered to educators and those offered to many in the private sector.

Jeff Pergament

Mr. Pergament asked much money could be saved if the district has to institute the 13 proposed jobs cuts. Mr. De Vita responded that \$639,000 would be saved.

Mary Caffrey

Mrs. Caffrey asked for clarification on how the 1.5% employee contribution toward health care would impact the district. Mr. De Vita explained that the district is currently part of the State health benefits program. With a current loss ratio of .77%, employees have a \$15 co-pay. Mrs. Caffrey suggested that like the township, the district consider a premium sharing option.

Alicia Parylak

Mrs. Parylak asked why only one administrative position is being lost as compared to 13 teaching positions. Mr. Mayer indicated that on a percentage basis one administrator equals 8% of the administrative team while 8% of the teaching staff translates to 24 positions.

Steven David

Mr. David suggested that the district consider ways to generate additional revenue such as naming rights and more expansive use of the district's facilities. He also asked for guidance on how to approach legislators.

Gabriella Manzanillo

Mrs. Manzanillo recommended that district officials post guidance and a letter template to legislators on the website. Mr. Mayer agreed and said that the district would follow through on this suggestion.

Michael Smith

Mr. Smith expressed his hope that, from a priority standpoint, co- and extra-curricular activities were considered for reductions before teaching staff. He noted that, as an employee of the insurance industry, today's reality calls for a shift in the burden of benefit costs.

Tom Giachetti

Assuming that the Association will consider a wage freeze and the 1.5% health insurance contribution is instituted, Mr. Giachetti indicated that he, as a taxpayer, would be willing to absorb the additional costs associated with keeping the teachings staff.

Barry Haftel

Mr. Haftel asked what percentage of teachers are utilizing medical benefits. Mr. De Vita responded that approximately 80% of employees currently utilize the medical benefits provided by the district. He also noted that non-tenured staff is required to contribute toward dental and prescription benefits for spouses and family members.

Mr. Haftel asked if consideration had been given to cutting one of the two existing Assistant Principal positions at PRMS. Mr. Mayer explained that as Robbinsville's student to administrator ratio is well above average, that no consideration will be given to cutting one of these positions.

John Ruch

Mr. Ruch noted that, comparatively, our elementary schools are very large which is why we need to keep the administrators we have currently at the school level. He asked how unemployment would be funded for the individuals whose positions are eliminated. Mr. De Vita explained that the cost for each employee's health benefits would be transferred to the unemployment line.

Sonya Walter

Mrs. Walter works with senior citizens. She indicated that they do not feel connected and stressed the importance of building partnerships with them. Mrs. Walter recommended that the district ask the teachers to make the difficult choice to take less.

Donna Simone

Mrs. Simone asked why the State did not take advantage of the Race to the Top grant. Mr. Mayer said that the State did submit an application but it was not accepted in the first round.

Ray Hart

Mr. Hart recommended exploring a new education model by partnering with other districts to save costs. He suggested considering a change in the school calendar as well as ending participation in unfunded mandates.

Kerry Godfrey

Kerry Godfrey suggested that the district consider reducing kindergarten to a half-day program to save money.

Debbie Baier

Mrs. Baier thanked district officials for focusing on residents concerns. She encouraged residents to write to their legislators to protest the Governor's arbitrary funding cuts.

Jim Guididas

Mr. Guididas asked for the average size of RHS elective classes. Mr. Mayer indicated that they average 20 but some are in the teens.

Sue Brzezynski

Mrs. Brzezynski expressed an opinion that transportation costs could be reduced if sidewalks were completed. Mr. De Vita indicated that he learned in recent conversations with the township that grant opportunities are available for sidewalk construction.

Ellen Gallagher

A lunch aide at PRMS, Mrs. Gallagher noted that over 1000 students attend the school. She said that having two Assistant Principals for such a large number of students is necessary.

Elizabeth Breden

Mrs. Breden asked if it is legal for the State to extend cuts to Special Education. Mr. Mayer indicated that in spite of the cuts – legal or otherwise – the District will continue its Special Education programs. Mrs. Breden inquired about the possibility of instituting furlough days for staff. Mr. Mayer explained that things like the institution of furlough days are all part of the negotiation process and not something the district can impose.

Dave Boyne

Mr. Boyne, a township councilman, indicated that the township is actively pursuing sidewalks from Saran Woods that are not dependent on grant funding.

Kevin Schick

Noting the limitations posed by the funding reductions, Mr. Schick asked what would be saved if the district reaches a point where it can reconsider cuts. Mr. Mayer said that the first priority would be protection of classrooms and teaching staff after which district officials would begin at the top of the priority list established by the Board in November.

Noushin Kanini

Mrs. Kanini stated that residents do not have an additional \$550 for taxes but that the community would be happy to assist the district in other ways, i.e. cutting grass, painting buildings, and supporting a letter writing campaign. She requested that the powerpoint presentation be posted on the website.

Al Wolochuk

Mr. Wolochuk asked how far into the future would this year's cuts affect the district. Mr. Mayer stated that given an average enrollment growth of 4% and a cap of 2.5%, the current situation will pose irreparable harm to the district. He noted that it will take a long time to recover.

President Mike Reca thanked residents for their attendance and closed the Hearing of the Public.

Several Board members reaffirmed their commitment to each other and to the public to continue to look for every efficiency possible.

Further discussions ensued regarding a list of potential budget cuts created at the March 18th budget workshop during a brainstorming session as well as clarification of the budget timeline. One member commented on the need for continued community support to help combat the spread of misinformation.

Mr. Mayer stated that, in spite of wrestling with decisions that belie its core belief system, the district places immeasurable significance on the value of early learning. Additionally, Mr. Costanza asked if the public would be made aware of the specific cuts before Election Day. Mr. Mayer indicated that the district anticipates holding additional information sessions before April 20th.

JoAnn Laskey

Mrs. Laskey noted that she is concerned that the public might perceive kindergarten as a target area for cuts. Mr. Mayer stated that any reductions that take place will be across the board as opposed to on one single area.

Jody Stevens

Mrs. Stevens asked if aides are required by law at Sharon. Mr. Mayer indicated that they are but that volunteers may be a possibility.

XIV. OLD BUSINESS

Mrs. DeVito thanked the community for their efforts in attempting to help pass the referendum.
