ROBBINSVILLE BOARD OF EDUCATION PUBLIC SESSION MINUTES

August 31, 2010

I. CALL TO ORDER PUBLIC MEETING

President Mike Reca called the August 31, 2010 meeting of the Robbinsville Board of Education to order at 7:10 PM.

II. STATEMENT OF PUBLIC MEETINGS

The New Jersey Open Public Meeting Law was enacted to insure the rights of the public to have advance notice of and to attend the meetings of public bodies at which any business affecting their interests is discussed or acted upon. In accordance with the provisions of this act, the Robbinsville Board of Education has caused notice of this meeting to be published by having the date, time and place thereof posted in the Trenton Times and the Township of Robbinsville Bulletin Board. In addition, this notice was faxed to the Trenton Times and posted at Windsor School, Sharon School, Pond Road Middle School and Robbinsville High School.

III. PLEDGE OF ALLEGIANCE

IV. ROLL CALL

Mrs. Boyne, Mrs. DeVito, Mrs. Gange, Mr. Kasper, Mr. O'Grady, Mr. Reca, and Mrs. Silvestrov were present. Mr. Halm was absent. Others present included Superintendent Steven Mayer, Assistant Superintendent Kathleen Foster and School Business Administrator / Board Secretary Robert M. De Vita.

V. BOARD CANDIDATE INTERVIEWS

The Board held "round-robin" interviews for the open seat vacated by Melissa Foy on June 29, 2010. The following individuals applied for the position:

VI. EXECUTIVE SESSION – 8:05 PM

On motion of Mrs. Boyne and seconded by Mrs. Gange and carried by a vote of 7 - 0, the Board voted to convene in Executive Session to deliberate and select a candidate.

VII. RECONVENE PUBLIC SESSION – 9:51 PM

VIII. APPOINTMENT OF NEW BOARD MEMBER

On motion of Mrs. Gange and seconded by Mrs. Silvestrov and carried by a vote of 6 - 1 with Mr. O'Grady dissenting, Dr. Vincent Costanza was nominated as a replacement Board member for the 2010-2011 school year until the annual school elections on April 27, 2011. Mr. Halm was absent.

IX. OATH OF OFFICE

Mr. De Vita administered the Oath of Office to Dr. Costanza.

X. BOARD PRESIDENT'S REPORT – Mr. Mike Reca

Mr. Reca thanked the candidates for their interest in the Robbinsville Board of Education and noted that selection process was especially challenging due to the exceptional quality of each applicant. He asked the candidates to continue supporting the Board by actively attending meetings.

XI. SUPERINTENDENT'S REPORT – Mr. Steven J. Mayer

Mr. Mayer welcomed seven new teachers to the district. He informed the Board and members of the public that faculty reports for their first day on September 2 and school will open on September 7. Mr. Mayer also indicated that Freshmen orientation took place earlier in the day as did the final walk through of each building.

XII. SCHOOL BUSINESS ADMINISTRATOR'S REPORT – Mr. Robert DeVita

Mr. De Vita informed the Board that the annual audit was currently in process. He discussed the Energy Education Specialist interviews and noted the high caliber of all applicants.

Mrs. DeVito reported that Robbinsville High School has been ranked for the first time by *New Jersey Monthly*. This bi-annual ranking rates New Jersey high schools in terms of academic performance and other criteria. Robbinsville High School ranked 109th among all high schools in the state.

B. EDUCATION, DEVELOPMENT & POLICY - Mrs. Florence Gange

Mrs. Gange reported that the Education, Development & Policy Committee met on August 10th. Discussion involved policies, NCLB funding, Literacy / Math coaches, *Performance Matters* software, and book selection and approval process.

C. PERSONNEL – Mrs. Florence Gange

Mrs. Gange reported that the Personnel Committee discussed the role and function of Team Leaders and Administrators at PRMS and the open Curriculum Supervisor position.
