Board President Mike Reca called the January 25, 2011 meeting of the Robbinsville Board of Education to order at 6:10 PM.

Others present included Superintendent Steven J. Mayer, Assistant Superintendent Kathleen A. Foster, and School Business Administrator Robert M. DeVita.

V. MOVE TO EXECUTIVE SESSION

On motion of Mrs. DeVito and seconded by Mrs. Gange and carried by a vote of 6-0, the Robbinsville Board of Education voted to move to Executive Session at 6:11 PM.

VI. RECONVENE PUBLIC SESSION

On motion of Mrs. Boyne and seconded by Mr. O'Grady and carried by a vote of 6-0, the Robbinsville Board of Education voted to reconvene in Public Session at 7:02 PM.

VII. BOARD PRESIDENT'S REPORT – Mr. Mike Reca

Mr. Reca extended the Board's congratulations and appreciation to the following:

VIII. SUPERINTENDENT'S REPORT - Mr. Steven J. Mayer

Mr. Mayer introduced Anirudh Bandu to the Board. Anirudh provided a presentation detailing plans to create a community vegetable garden at Sharon Elementary School. Creation of the garden will help him complete the requirements necessary to achieve the rank of Eagle Scout.

Mr. Mayer reported on the 2011-2012 budget indicating that the State is expected to provide aid figures to districts by February 24th. He noted that the site managers at each school have done an exceptional job with the budget process and emphasized the importance of continued transparency.

IX. SCHOOL BUSINESS ADMINISTRATOR'S REPORT – Mr. Robert DeVita

Mr. DeVita reported on the Board vacancies. This year Robbinsville has three 3-year seats and one 1-year seat available. All applications are due to the Board Office by March 8, 2011.

Mr. DeVita addressed the budget timeline. The Board will then schedule a meeting to adopt a tentative budget. The process will culminate with the April 27 annual election.

of Robert M. DeVita's certification to the Director of the Division of Local Government Services.
