VII. SUPERINTENDENT’S REPORT – Dr. Steven J. Mayer

Noting that every year the Board is required to sign off on a Statement of Assurance attesting to compliance in the areas of Instruction and Program, Governance, Fiscal Management, Personnel, and Operations, Dr. Mayer provided a report to the Board on the district’s current NJQSAC status. He said that this year the district scored 100% in each of the five areas.

In his report, Mr. Haines noted that the district received an “Unqualified” audit opinion. This represents the best opinion that can result from an audit. An audit synopsis is attached (pages 23 – 24).

Mrs. Gange expressed appreciation to Mr. DeVita and his team for their efforts in creating a much improved financial position for Robbinsville Schools.

XII. COMMITTEE REPORTS

Mrs. Gange reported on the following matters that were discussed at the Personnel Committee meeting on November 21, 2011.

- Mrs. Gange offered congratulations (with regret) to Baninder Mahabir on her new position as an elementary school principal in Edison. Other Board members echoed this sentiment. She noted that the committee strategized about ways to retain individuals in the position as Supervisor of K – 8 Curriculum and Professional Development. A cost and benefit analysis is planned as well as additional discussion.

Mr. Reca asked if the district has a formal procedure for accepting volunteers. Dr. Mayer indicated that the current role of volunteers is to help the coaches adding that volunteers are never alone with students. Mr. Reca requested that the Personnel Committee examine this issue.

D. FINANCE, FACILITIES, & TRANSPORTATION – Mrs. Carol Boyne

Mrs. Boyne reported on the following matters resulting from the November 16, 2011 meeting of the Finance, Facilities and Transportation Committee.

- Parking behind RHS Football Stadium – The area is not intended for parking rather the paved access road is intended for emergency use only. A quote in the amount of \$1,600 for a gate was obtained.
- Grounds – Challenges during RHS spring sports / Resources to be redeployed for optimal utilization.
- E-Rate – To date the district has received \$34,000.
- SIS RFP – 2 finalists for Student Information System including Genesis and Power School. A team of five will take part in site visits to districts currently utilizing these systems.
- Audit – Presentation at November 29 Board meeting / 1 minor finding
- Transportation – Bridge closings / Dapper penalties
- R.E.D. – System developed for late payments
- Sharon Roof Replacement
- Banking RFP in progress
- PPA – Considering re-issue of RFP

Mr. Kasper inquired about the 2012-2013 budget timeline. In response, Dr. Mayer indicated that each committee will conduct a review of priorities in December. In January there will be a special budget / facilities meeting to provide time for further budget discussion. Dr. Mayer also noted that a Budget Review Committee, comprised of community members, will be established again this year.

E. NEGOTIATIONS – Mr. Thomas Halm

In Mr. Halm's absence, Mrs. Boyne reported that the Negotiations Committee did not meet. She said that a Fact Finder has been assigned but, as yet, no dates have been set. Dr. Mayer said that in according to the Board Attorney, the next meetings will take place in early February.

A. RAMY BEKHJET

Inquiring about the Student Activity Fees, RHS Senior Ramy Bekhjet asked how these funds are used. Dr. Mayer explained that the fees fund approximately 8% of the Athletic and Co-Curricular programs. He noted that the money goes into the General Fund and that exceptions are made for individuals experiencing hardships. Mrs. Boyne added that several years ago the Board and administration made the decision to implement the fees rather than cut programs.
