VI. SUPERINTENDENT'S REPORT – Dr. Steven J. Mayer

• Annual Budget Hearing – 2015-2016 Budget Presentation (Attachment #1)

Before beginning the 2015-2016 budget presentation, Dr. Mayer indicated that Teacher Appreciation Week begins on May 4th. During the budget presentation, Dr. Mayer informed the Board and members of the public that the 2015-2016 budget included, for the first time in many years, no tax increase. Because the health cared loss ratio was better than projected, the district was able to allocate funds to reduce the tax levy and to the technology initiative.

Board members commented and asked for clarification on a variety of topics related to the budget.

- Chromebook Initiative Will be implemented in the following stages: Year 1 Grades 3 & 5 / Year 2 Grades 4 & 6 / Year 3 Grades 7 & 8 / RHS students will be asked to bring the device of their choice. Dr. Mayer indicated that the district may consider a survey of students in grades 9-12 to determine what kind of devices they will bring in.
- Chromebook Insurance
- SES Retirees 1 FTE to replace 4 retirees Breakage is not budgeted, rather it is utilized for sick leave payouts / maternity leave replacements.

VII. SCHOOL BUSINESS ADMINISTRATOR'S REPORT – Mr. Robert DeVita

School Business Administrator Robert DeVita informed the Board that Senator Greenstein sent a letter in response to a resolution passed at the March 24, 2015 meeting calling for amending state law to allow for school district capital costs to be placed outside of the 2% spending cap. A. EDUCATION, DEVELOPMENT & POLICY – Mrs. Florence Gange

Mrs. Gange reported on the following matters discussed during the April 14, 2015 meeting of the Education Development and Policy committee.

C. FINANCE, FACILITIES, & TRANSPORTATION - Mr. Thomas Halm

Mr. Halm reported on the following matters discussed during the April 28, 2015 meeting of the Finance, Facilities and Transportation meeting.

- Transportation The committee reviewed the monthly transportation report. One item of note was the closure of Gordon Road. The impact on busing has been worked out.
- Budget The committee reviewed the changes to the budget that occurred due to a Horizon increase of 5% versus the 16% budget projection
- Construction The district continues to close out the remaining work and approved change orders. The remaining issue is the price to make some changes to the road in the back of Sharon including adding some curbing and widening the road by the modular as well as the addition of a few speed bumps, crosswalks and an asphalt play surface. The district is currently awaiting a final price from Lighton.
- Attorney RFP The committee discussed the need to finalize a date for the interviews. Dr. Mayer proposed two dates in last week's update, May 20 or May 21.
- Facility Rentals The committee noted that the district continues to do very well with facility rentals and discussed providing Mrs. Keener with assistance. The Superintendent and BA are proposing a \$5,000 stipend for an assistant.
- Policy The committee discussed the BOE policy regarding the election of BOE officers.
- Custodial RFP Three proposals for custodial services have been submitted. They are being reviewed with a consultant from Edvocate. The district anticipates making a recommendation to award the contract at the May meeting.

XI. HEARING OF THE PUBLIC

A. ALEXANDRA HALM

A fourth grade student, Alex Halm asked why students in grades 4 and 6 are not permitted to play on the playground at recess. Dr. Mayer asked if Alex had approached Mr. Gizzo with her question. When she indicated that she had not, he said that he would help to make a conversation take place.

B. NUSHIN KAHANI

Mrs. Kahani addressed the Board about the following matters.

- Pay it Forward Mr. Halm said he mentioned this program to Mayor Fried.
- Amazon Can they donate technology? Dr. Mayer explained that they donated 50 kindles to SES
- New Housing How many new students are anticipated? Dr. Mayer indicated that within the next several years the district anticipates about 300 new students due to new development.
- \$0.00 Tax Increase Is it possible to ask residents to pay a little now to assure funds for unanticipated expenses? Mr. DeVita said there are too many variables. Dr. Mayer indicated that the district takes a strategic, multi-year approach to planning.
- PARCC Issue with playing catch up in class after PARCC / too much work / too much stress for kids. Dr. Mayer noted that RHS carried on with day to day programming during PARCC but there may be other variables such as spring break that have come into play. He suggested that Mrs. Kahani speak with her children's teachers.
- Planes flying over SES Signs are too small / She has addressed at township level.
- Summer Reading Explained to the Board that she plans a book club for her children's friends and their parents. She indicated that the AP students have too much work over the summer and asked if they can be excused. Dr. Mayer assured her that they can handle the work load.

XII. APPROVE ANNUAL RESOLUTIONS

On motion of Mr. Kochberg and seconded by Mrs. DeVito and carried by a vote of 8-0, the Robbinsville Board of Education voted to adopt the 2015-2016 Proposed Budget as indicated. Dr. Costanza was absent.

Board Comment

Board members indicated that they are extremely proud that the district, in keeping with the township and county budgets, has submitted a budget for 2015-2016 with no increase to tax payers.

A. ADOPTION OF 2015-2016 PROPOSED BUDGET FOR ROBBINSVILLE SCHOOLS

Whereas the Robbinsville Board of Education adopted a tentative budget on Wednesday, March 11, 2015, was submitted to the Mercer County Executive Superintendent of Schools for approval, and whereas the tentative budget was advertised in the legal section of the Trenton Times on April 24, 2015, and whereas the proposed budget was presented to the public during a hearing held in the Robbinsville High School on April 28, 2015, and whereas the total amount of the 2015 - 2016 budget is as follows:

Be it resolved that the Robbinsville Board of Education adopt the 2015 – 2016 Annual School Budget as detailed above. Be it further resolved that the following amount to be raised by the local tax levy for the General Fund is \$34,216,004 and Debt Service Fund is \$5,286,021 for a total tax levy of \$39,502,025.

The 2015-2016 budget general fund tax levy, as per N.J.S.A. 18A:75-38 includes the use of banked cap in the amount of \$18,829 for increases to health benefit costs.

On motion of Mr. Halm and seconded by Mrs. Ciaccio and carried by a vote of 8-0, the Robbinsville Board of Education voted to approve resolutions XII B - E as indicated. Dr. Costanza was absent.

B. <u>APPROVE MAXIMUM EXPENDITURE FOR 2015-2016 TRAVEL</u>

Motion to approve the maximum expenditure for travel for the 2015 – 2016 school year for all staff and board members is \$130,000 in accordance with N.J.A.C. 6A:23B-1.2(b). The Robbinsville Board of Education also approves that an annual school year threshold of \$1,500 per staff member be established for regular business travel where prior Board approval shall not be required unless this annual threshold for a staff member is exceeded in a given school year. The Robbinsville Board of Education also certifies that as of April 28, 2015 the district has expended \$79,282.31 for approved travel for staff and board members for the 2014 – 2015 school year.
